### ORDINANCE NO. 2023-07

#### AN ORDINANCE OF THE CITY OF UNALAKLEET AMENDING CHAPTER 13.08 BALER FACILITY AND SOLID WASTE LANDFILL SECTION 13.08.230 ESTABLISHMENT OF RATES OF THE UNALAKLEET MUNICIPAL CODE

WHEREAS, the cost of efficiently maintaining both a transfer site and a landfill up the hill includes personnel, equipment, maintenance, fuel, and other expenses;

WHEREAS, the City needs to recoup these costs by means of user fees, and the fees need to reflect the fluctuation in costs to provide the service;

**NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE CITY OF UNALAKLEET, ALASKA:**

**Section 1:**     **Classification.** This ordinance is of permanent nature and shall be codified in the Unalakleet Municipal Code.

**Section 2:**     **Severability.** If any provisions of this ordinance or any application thereof to any person or circumstance is held invalid, the remainder of this ordinance and the application to other persons shall not be affected hereby.

**Section 3:**     **Amendment of Chapter 13.08.** Unalakleet Municipal Code Section 13.08.230, Establishment of Rates, is hereby amended to read as follows, with the new language underlined:

#### **13.08.230     Establishment of rates.**

Large User	\$136.50 per month
Medium User	\$63.00 per month
Small User	\$31.50 per month
Used oil, over 5 gallons	\$2.50 per gallon
Construction debris, nonhazardous	\$50.00 per cubic yard
	(as measured by volume)
Other than material, junk, scrap metal	\$125.00 per cubic yard
	(as measured by volume)

The city council may establish or alter fees and billing methods for the use of the city owned solid waste disposal facilities.

**Section 3:**     **Effective Date.** This ordinance shall be published as provided by law and shall be effective upon adoption.


