Ordinance 11-04

AN ORDINANCE AMENDMENT FOR THE CITY OF UNALAKLEET, SETTING THE AGE LIMIT TO DRIVE/OPERATE ATV'S, SCOOTERS, MOTORCYCLES, SNOWMACHINES AND SIDE BY SIDES;

AND TO EXPAND JURISDICTION TO THE CITY BOUNDARY.

BE IT ORDAINED AND ENACTED BY THE CITY OF UNALAKLEET, ALASKA AS FOLLOWS:

Section 1: Classification. The Ordinance shall be codified in the Unalakleet Municipal Code.

Section 2: Age-Vehicle Operations. No person under the age of fourteen (14) shall operate an ATV, Scooter, Motorcycle, Snowmachines and Side by Side (any motor driven vehicle) unless under the direct supervision (on the same vehicle) of responsible individual who is at least 18 years of age or older.

Section 3: Parental/Guardian Responsibility. A parent or guardian of a minor under the age of fourteen (14) violates this ordinance if he or she knowingly permits, or by insufficient control, allows their child or ward to operate a motor driven vehicle in violation of this ordinance. Indifference as to the activities or whereabouts of the minor under the age of fourteen (14) shall be prima facie evidence of insufficient control.

Section 4: Fines: Any minor and/or the minor's parent or guardian cited for a violation of this ordinance is guilty of an infraction and is punishable by a fine of:

- 1. Twenty-five dollars for a first offense:
- 2. Fifty dollars for a second offense;
- 3. Seventy-five dollars for a third offense;
- 4. One hundred dollars for a fourth offense and each one thereafter.

Section 5: Effective Date: This ordinance shall be published as provided by law and shall be effective upon adoption.
